# Item No. 57.1 Confirmation of Minutes of the last (56th ) Board Meetings held on 29.11.2012.

The Minutes of 56<sup>th</sup> Meeting of the Board of Directors held on 29.11.2012 were circulated to all the directors vide no. D-2(161)/24264-86 dated 27.11.2012. The Board confirmed the same.

# Item No. 57.2 Revised Audit Report submitted by Statutory Auditors.

It was informed to the Board that in the 53<sup>rd</sup> Board Meeting held on 06.09.2012 Annual Accounts and Audit Report thereon submitted by the Statutory Auditors were approved which were submitted for

supplementary Audit by A.G. Rajasthan under sec. 619 (4) of the Companies Act 1956 and the same was concluded on 19.10.2012. However, on 26.11.2012 Statutory Auditors submitted their revised Auditor's Report. Following additional observation has been given by the Statutory Auditors in the revised Auditor's Report:

"With reference to note no. 19 to the Balance Sheet, disclosures under AS-15 are mandatory for the Corporation and should be disclosed in significant manner. Corporation has not made the disclosures required to be made in prescribed format as per AS-15 'Employees Benefits' due to non availability of required information in proper manner, which is non compliance of AS-15. Non disclosure of such mandatory information as per AS-15 constitute a significant non compliance of Companies Act under sub-section 3C of section-211".

After receipt of Revised Auditor's Report from Statutory Auditors the matter was brought to the notice of Principal Accountant General, Rajasthan, Jaipur on 27.11.2012. As per the advice of A.G. Rajasthan, the Revised Auditor's Report is to be placed before the Board of Directors for adoption.

The Board was, therefore, requested to consider adoption of Revised Auditor's Report.

After discussions the Board adopted Revised Auditors Report with following reply to be included in the Director's Report:-

"Disclosures under Accounting Standard-15 will be made in the prescribed format of Employee Benefits from the next financial year positively."
